



2026 Board of Directors Election Q&A

Q: How do you access the voting website?

A: Go to www.veridiancu.org/election and click on **Vote Now** to access the voting website. Paper ballots are not available. If you are unable to vote online, please vote electronically at a Veridian branch near you.

Q: Who is eligible to vote?

A: To be eligible to vote, you must:

- Be 16 years of age on or before March 11, 2026.
- Be the primary member on the account. Joint members are not eligible to vote.
- Have a birthdate on file with the credit union.
- Have a social security number on file with the credit union.

Q: How do I find my Voter ID?

A: This information was sent to you by email on March 25 from veridiancuhelp@cues.org. If the email is not in your inbox, please check your spam folder. If you did not receive the email, or do not have an email address on file with Veridian, please chat online at veridiancu.org, call 800-235-3228, or stop by a branch to receive your login information.

Q: What should I do if I can't log in to vote?

A: Please make sure you are using the correct Voter ID. If you have more than one phone number, please try an alternative number. If you're still unable to log in, please chat online, call 800-235-3228, or stop by a branch to receive your login information.

Q: Am I required to vote on each ballot?

A: No, you are not required to vote on each ballot. There are two ballots, one for directors and one for associate directors. The Nominating Committee nominated three candidates to the director ballot. Each director candidate is required to receive confirmation yes votes of 50% or more to be elected. The Nominating Committee nominated three candidates to the associate director ballot. The associate director candidate who receives the most votes will be elected.

Q: Can I vote more than once?

A: Each member is entitled to one vote, regardless of the number of accounts, except for a business account. If a member has a business account, they may cast a second vote for the business.

Q: If I vote online, can I attend the Annual Meeting?

A: Yes. Members who cast their vote online between March 25 and April 23 can attend the virtual Annual Meeting on Tuesday, April 28. Voting is not allowed during the Annual Meeting.



Q: Can I vote if I just opened an account?

A: To be eligible to vote, you must be a member on or before March 11, 2026.

Q: Can I vote at a Veridian branch?

A: Yes. If you are having trouble accessing the voting website or do not have access to a computer or mobile device, you can visit a branch to vote electronically.


Q: When is the Annual Meeting?



A: No. Voting is not available during the Annual Meeting. Electronic votes must be submitted between 12:01 a.m. on Wednesday, March 25 and 11:59 p.m. on Thursday, April 23. The voting website is www.directvote.net/Veridian.

Q: How can I attend the Annual Meeting if I don't have a computer?

A: You can listen to the Annual Meeting over the phone by dialing 415-655-0001, entering the meeting number 2497 778 3610 and the password 2026. You will be asked to enter the pound key (#) after entering the meeting number and password.
